## The Vermilion Cemetery Memorial Fund

Town Council developed the Vermilion Cemetery Memorial Fund to be used for perpetual care of the cemeteries. Tax deductible donations are received by the Town and placed into an interest bearing reserve. The interest from the account is used to help defray the cost of maintaining the cemeteries. It is anticipated that if the reserve becomes large enough and the cemeteries are full, the interest from the reserve will pay for their yearly maintenance.

#### Public Cemetery & Columbarium

44<sup>th</sup> Street south on Highway 16, or traveling south on Highway 41, proceed over the overpass, turn east onto the golf course road and follow it for 1 km past the golf course.

#### Catholic & Ukrainian Catholic Cemetery

48<sup>th</sup> Avenue and 32<sup>nd</sup> Street. Approximately 2 km east of Fountain Tire/Southview Trucking or 2 km north of Agricore United Distribution on Highway 16.

## Cemetery Bylaw Highlights

In all interments, with the exception of urn plots, caskets shall be placed in an outer receptacle, of which the standard of construction shall be a concrete rough box.

Grave covers are not allowed.

Flat markers may be placed on a grave plot at the head or foot, but must be flush with the surrounding ground.

The Town of Vermilion is responsible for opening/closing all burials and inurnments.

All artificial wreaths, flowers and other such tributes left on a grave plot may be removed by cemetery caretakers after the elapse of two months after interment.

The Town shall not be responsible for any damages accidently or willfully inflicted to any marker, monument or other surface structure not installed by the Town within the cemeteries.
