





**TAX AUTO PAYMENT PLAN IS A PAYMENT PLAN WHEREBY PROPERTY OWNERS CAN PAY THEIR ANNUAL PROPERTY TAX WITH CONSECUTIVE MONTHLY INSTALLMENTS RATHER THAN A SINGLE PAYMENT ON OR BEFORE THE DUE DATE.**

**You Can Enroll if:**

- There are no taxes owing from previous years
- You don't pay your taxes through a mortgage
- You have your completed application, located on the back of this page, in by Dec 15th before the next calendar year
- Your application is received by April 15th (final date for late application) accompanied by payment of the missed payments (Jan, Feb, March)

**Monthly Payments are Calculated as follows:**

Your 2022 monthly payment plan amount for January to April will be calculated based on your 2021 tax levy divided by 12. These payments will be withdrawn on the last banking day of each month.

When your 2022 tax notices are prepared, the notice will show the adjusted monthly payment necessary to settle the 2022 taxes by December 31, 2022. The adjusted monthly payment will be withdrawn from your account for the May 2022 withdrawal and will continue as your monthly payment until the following year's tax notice is distributed. Once again there will be an adjustment amount in May 2023 and so on. You will continue on the plan from year to year until you give Town Hall notice of cancellation or the property is sold.

**Selling Property/Change of Bank Account**

If your property is sold or title transferred, or you have a change in bank accounts, it is the responsibility of the participant to inform the Tax Department. We require changes by the 15th of the month, to be effective on the next withdrawal.

This program is a "Win/Win" for both the town and taxpayer, tax payments are collected early in the period of time prior to July 15, but also a penalty is not levied against the payments collected after penalty date from July 16 to December 31.

5. In the event of a sale of the above noted property or a change in bank accounts, I/we will notify the Town of Vermilion at least 15 days prior to the next payment date, to arrange for cancellation, or to provide the new bank account information and a cheque marked "VOID".
6. I/we acknowledge that delivery of authorization to the Town of Vermilion constitutes delivery by me/us to the branch of the financial institution of which I/we maintain an account and that such financial institution is not required to verify that the payment(s) are withdrawn in accordance with this authorization.
